### **Sale of 2025 Rice Harvest and RMB Finalisation Process**

The Rice Marketing Board for the State of New South Wales (the RMB) is transitioning to the end of vesting by 1 July 2026. Throughout this transition phase the RMB will continue its day-to-day reporting, engagement and compliance on any vested rice grown in northern NSW before 1 September 2024 and in southern NSW before 1 July 2025. In this regard, it will continue to administer the Rice Marketing Act 1983, the Rice Marketing Amendment Act 2024 and the Sole Exclusive Export Licence (SEEL) until it ceases operation.

**As part of the RMB compliance monitoring we would like to remind rice growers in Southern NSW that they are still required to sell their NSW rice crop to Authorised Buyers in this final year of vesting.**

Separately, there has been enquiry from some stakeholders regarding the process steps for the finalisation of the RMB. The process required to ensure complete windup by July 1, 2026, have been mapped in detail and shared with the Department of Primary Industry and Regional Development (DPIRD). At a high level, the RMB activities underway and the tasks in its remaining tenure can be broken down into three activity areas. These are:

**1. Business as Usual Compliance Activities**

Ongoing crop auditing, export review, verification, issues management, compliance monitoring, communication and engagement.

**2. Mandatory Statutory Reporting**


Financial reporting, annual reporting, regulatory reporting, reporting to NSW rice growers and an annual general meeting.

**3. Wind-down Tasks**

Finalisation of payables and entitlements, closure of accounts, final reporting to government agencies, archiving, and payment of residual funds to a NSW Public Authority.
